1. Curriculum

This course is addressed to students enrolled in a Master program of the University of Hohenheim in your second semester or higher:

- As an Economics student, you can choose this course as a free elective module.
- As an IBE student with intake 2019 or earlier, this course replaces the compulsory module "The Microeconomics of Globalization" in the major "International Economics".
- As an IBE student with intake 2020 or later, you can choose this course as one of your modules in the major "International Economics".
- As a HMM student, you can choose this module as a free elective module

If you are a student from another Faculty or an exchange student (Double Degree or free mover), please consult your (exchange) program coordinator.

2. Course organization

The course is taught in English. We follow an **Inverted Classroom Model** with the following ingredients. We deliver the course content mainly online via our learning platform (ILIAS). Learning units will be made available on a weekly basis. You are expected (i) to study the online course (e.g., videos, slides, notes), (ii) to solve the Problem Sets, and (iii) to post open questions in Forum for content-related questions and discussions on ILIAS. The agenda below lists what to do & when.

In additional weekly in-class **Meet-up Sessions**, the previous learnings unit will be wrapped up (e.g., by discussing important points of the Problem Sets and questions posed on ILIAS). In some of the Meet-up Sessions, we will also deliver new content. Moreover, we will have **Mock Exam Session** where we explain important phrases used in the exam questions and answer your questions on the Mock Exam.

There will be a **Final Exam** (6 EP). The exam is an academic assessment that can be failed. You can earn up to 10% of the final assessment in advance by solving **Bonus Point Assignments**. We will inform you about the organization of Bonus Point Assignments in due course.

You have to **register for the Final Exams via the Examination Office** ("Prüfungsamt"). There will be one exam in the first examination period and a second exam at the end of the summer semester.
